1. Minutes of previous meeting

The minutes of the previous AGM were circulated. The minutes were confirmed as an accurate record.

2. Committee Reports

2.1 Chairperson's Report

Ali McKay provided the following report as Deputy Chair:

2022 has been a full and rewarding year for our garden. We were able to take advantage of a much-enlarged garden. Thanks go to City of Sydney for their ongoing support. There remain some outstanding issues to be worked through with our Council partners which include the tree planters - waiting patiently for appropriate soil and drainage to plant fruiting trees, and the dysfunctional orange sail, which drains rainwater directly into the garden beds making it impossible to plant out - we are in regular communication with the Council re remediation of these issues; and look forward to resolution.

We instigated a new garden management process which is working well. This means that we effectively have 3 different areas which reflect the interests of our active members - the western/ street area is known as the Rambling Potager garden, the middle area the Kitchen Garden and the eastern garden is planted with Bushfood edible plants. Each is tended by members who chose to work in one or more according to their interests and availability. A more detailed description of the philosophy of each of these areas is available on our website.

Our garden provides lots of opportunities to engage, including a very popular food scraps collection - saving such scraps from going into landfill, and providing material for much loved, and important compost and worm farms.

We are nearly ready to install a native beehive to join the little one gifted to us by one of our younger members.

We have more than 100 members, and countless visitors.

Anecdotally it seems that we continue to have a high level of community support. Overall it has been a satisfying year, which augurs well for the future of Twelve Fine Oranges, Kings Cross Community Garden.

I thank the committee members for 2021/22 and wish the incoming Committee smooth sailing.

2.2 Treasurer's Report

In the absence of Santana Eidel, who has resigned due to relocating overseas, Helen Panckhurst reported that as of 30 June 2022 the garden had received \$4,540.00 in income. Total expenditure for the year was \$9,983.72, which was in the main covered by the City of Sydney grant funds and spent on establishing the new gardens. At the time of the AGM, the garden had a cash balance of \$6,404.51.

 - (2) The total number of committee members is to be between 5 and 9

That Clause 35 Proxy votes not permitted is changed from:

35. Proxy Votes not permitted

Proxy voting must not be undertaken at or in respect of a general meeting.

to:

35. Proxy votes are permitted

Proxy voting may be undertaken at or in respect of a general meeting where votes are cast in writing.
